

#### **Preneed Funeral Arrangements Unclaimed Property**



Assembly Bill (AB) 293, (Kalra, Chapter 514, Statutes of 2021) now requires funeral establishments to contact the consumer of unclaimed preneed agreements and contracts so that those monies can be returned to the consumer or escheated to SCO Unclaimed Property.

AB 293 also requires funeral establishments intending to cease operations to inform both the consumer and trustee if they are transferring their preneed funeral contract to another funeral establishment or cancelling the contract.

The Bureau-approved forms are posted on the Cemetery and Funeral Board website at <a href="https://cfb.ca.gov/industry/industry.shtml">https://cfb.ca.gov/industry/industry.shtml</a> and are available for funeral establishments to use:

- Notice of Transfer of Preneed Contract or Agreement to Successor Funeral Establishment
- Notice of Cancellation of Preneed Funeral Contract or Agreement
